

Unifii Corporation LLP Privacy Policy

You have entered a "replicated website" of an Independent Affiliate for Unifii Corporation LLP (referred to herein as "Unifii Corporation", "our", "us" or "we") or through our corporate site unifii.io. These sites are operated by Unifii Corporation, and are hosted on the server of Unifii Corporations' third-party technology provider. The information you submit on the site is sent to and accessed by Unifii Corporation, as well as the Independent Contractor (referred to herein as "Affiliate" or "Preferred Member") to whom this Site is assigned (except as set forth in this privacy policy). By visiting this Site and providing information to Unifii Corporation you consent to the following privacy policy, use and disclosure of information.

INFORMATION COLLECTION

Unifii Corporation is the sole owner of the information collected on our websites and on the replicated websites that we provide for use by our Affiliates and Preferred Members (hereafter the "websites"). We collect information from customers and visitors to the websites at different points on the websites.

Personally Identifiable Information

Through your use of or visits to our websites, you may be required or requested to provide personally identifiable information to us. Personally identifiable information is any piece of information that can potentially be used to uniquely identify, contact, or locate a single person including names, addresses, email addresses, telephone numbers, and credit card or banking information.

Customer Information

Customers are required to provide contact information (such as name, mailing address, telephone number(s), and email address). Customers are also required to provide payment information (such as credit card, debit card, or checking account information). We use this information to maintain contact with customers, to process customer orders, and for billing purposes.

Profile Information

Unifii Corporation gathers and stores some information that it collects through cookies, log files, clear gifs, and/or third parties. Such information is not used to provide offers or create a profile of visitors to our websites ("users") which include visitors and customers. Profile information is not tied to a user's personally identifiable information, however, such information is aggregated to provide offers and improve the content of the site for the user.

INFORMATION USE & SHARING

Personally Identifiable Information

Unifii Corporation DOES NOT share personally identifiable information except with contracted service providers as may be necessary to: (a) process orders and/or returns and obtain payment; (b) complete an enrollment as a customer. We also provide personally identifiable information: (a) to upline Affiliate(s) as described herein; and/or (b) to the Affiliate on the Company's Affiliate locator feature on the Company's website; and/or (c) to assign a sales or enrollment lead to an active Affiliate.

Genealogy Information

Unifii Corporation provides certain information to Affiliates regarding Customers enrolled in an Affiliate's downline marketing organization. As a Customer of Unifii Corporation, your name, address, email address, telephone number, sales volume, and order history information will be

provided to other Affiliates as downline genealogy information. No other personally identifiable information will be shared with other Affiliates. Information relating to downline Affiliates is made available to Affiliates subject to a confidentiality and non-solicitation covenant in the independent distributor agreement that each Affiliate enters into with Unifii Corporation. However, Unifii Corporation does not warrant that other Affiliates will adhere to the confidentiality and non-solicitation covenants, and Unifii Corporation shall not be responsible for Affiliates' violation of these covenants.

Sales Information

If you make a purchase from an Affiliate through this Site, we will provide the Affiliate to whom this Site is assigned with your name, contact information, a description of the item(s) purchased, and the sales volume associated with the purchase. No other personally identifiable information will be shared with the Affiliates.

Aggregate Information (non-personally identifiable)

Unifii Corporation may share aggregated demographic information with our partners, vendors, suppliers, third party providers, and advertisers. This is not linked to any personally identifiable information.

Business Transitions

In the event Unifii Corporation goes through a business transition, such as a merger, being acquired by another company, or selling a portion of its assets, the personal information of customers and Affiliates will, in most instances, be part of the assets transferred. If as a result of the business transition, a customer's personally identifiable information will be used in a manner different from that stated at the time of collection, the customer will be given a choice consistent with our notification of changes section.

Lead Assignment and Affiliate Locator Features

Unifii Corporation occasionally will assign prospective sales and new customer leads to Affiliates. In these cases, we will provide the Affiliates the name and contact information of the customer or prospective customer. In addition, Unifii Corporation has an Affiliate Locator feature on its website. Pursuant to this feature, a prospective customer can locate a nearby Affiliate. In order to make the Affiliate Locator feature and the lead assignments effective, the company will provide the prospective customer with the Affiliates's name and contact information, which may include his/her telephone number, address, and/or email address.

COMMUNICATIONS FROM US

Special Offers and Updates

Unifii Corporation sends all Customers a welcoming email to verify password, username, and reference to terms and agreements signed for during the purchase process. All Customers will occasionally receive information on the Unifii Corporation business, products, services, special deals, and a newsletter.

Service Announcements

On rare occasions it is necessary to send out a strictly service related announcement. For instance, if our service is temporarily suspended for maintenance we might send customers an email. Generally, customers may not opt-out of these communications, though they can deactivate their account. However, these communications are not promotional in nature.

Customer Support

Unifii Corporation communicates with Customers via email, regular mail, support ticketing system and telephone on a regular basis to provide requested services and in regards to issues relating to their Unifii Corporation services. Such communications may be by email, regular mail, support

ticketing system or telephone. Unifii Corporation also communicates with customers by posting messages in the member site and through its mobile app.

Unifii Corporation reserves the right to amend or change this Privacy Policy at any time at its sole discretion. When material changes or amendments are made to the Privacy Policy, we will announce the same at our home page for a period of at least 30 days prior to implementation of the amended Privacy Policy.

Choice

Users are notified when their information is being collected by any outside parties (with the exception of IT providers, merchant services providers, and Google Analytics). We do this so users can make an informed choice as to whether or not they should proceed with services that require an outside party.

Unifii Corporation' websites may contain links to other sites. Please be aware that Unifii Corporation is not responsible for the privacy practices of such other sites. We encourage users to be aware when they leave our site and to read the privacy statements of each and every website that collects personally identifiable information. This privacy statement applies solely to information collected by Unifii Corporation websites.

California Online Privacy Protection Act Compliance

Because we value your privacy we have taken the necessary precautions to be in compliance with the California Online Privacy Protection Act. We therefore will not distribute your personal information to outside parties without your consent.

Children's Online Privacy Protection Act Compliance
